## Multi-Pass Agreement

**By initialing this agreement I acknowledge and agree to the following terms:**

- \_\_\_\_\_ Multi-Pass holders *are not considered "members"* for the purposes of purchasing fitness passes or receiving activity discounts.
- \_\_\_\_\_ Multi-Passes are a contractual commitment. It is the policy of the Parks and Recreation Department to consider cancellations, transfers, suspensions and refunds *only under uncontrollable extenuating circumstances*. Any such request **must be submitted in writing to the Recreation Manager and must include supporting documentation**.
- \_\_\_\_\_ Multi-Passes are only valid for the individual purchaser and cannot be shared, transferred, or donated to another individual.
- \_\_\_\_\_ Multi-Pass access to the facility is available only when the facility is open. Passes will not be pro-rated for closures due to holidays, maintenance, weather, etc.
- \_\_\_\_\_ Multi-Pass rates may increase at the time of renewal.
- \_\_\_\_\_ All patrons must check in at the front desk or at the outdoor pool by using their multi-pass cards each time they use the Community Recreation Center or Outdoor Pool. Children under 3 are free and are not required to have a membership or multi-pass card.
- \_\_\_\_\_ Multi-Pass cards remain the property of the City of Laramie and must be returned if requested.
- \_\_\_\_\_ Children, 11 years old and under must have a person 18 years of age or older with them within the facility at all times.
- \_\_\_\_\_ Youth, 12 years of age and older may be within the facility unaccompanied by an adult.
- \_\_\_\_\_ When using swimming pools, children 8-12 years old must have an adult with them in the pool area at all times. Children under 8 years of age must be directly supervised in the water at all times and children 5 years and under must be within arm's reach of an adult who is in the water with them at all times.
- \_\_\_\_\_ Members and visitors of all ages must abide by all regulations, policies, and procedures of the City of Laramie, Parks and Recreation, and Community Recreation Center, or privileges may be revoked or suspended. Appeal procedures are available, and will be provided to members and visitors upon request.
- \_\_\_\_\_ The City of Laramie will not be responsible for lost or stolen articles, please use a lock to secure your belongings.
- \_\_\_\_\_ I understand that this agreement is an instrument for payment of the Multi-Pass purchased and I am obligated to fulfill this agreement completely. In the event that I fail to make the payments as outlined on page 1 of this document, I am responsible for all costs and expenses, including attorney fees and collection fees, incurred by the City of Laramie in collecting the balance due. A \$25 fee will be charged for any check returned or ACH, credit or debit payment declined due to non-sufficient funds.
- \_\_\_\_\_ All members are encouraged to obtain their physician's advice and permission before entering into any physical activities or programs. Participation in any activity or program is at the member's own risk. In case of an emergency, the Recreation Center will contact 911 for emergency assistance.

I understand and acknowledge that use of the facilities, equipment and services provided by the City of Laramie involves certain inherent risks. Inherent risks as defined under Wyo. Stat. § 1-1-122, the Recreation Safety Act, means those dangers or conditions which are characteristic of, intrinsic to, or an integral part of any sport or recreational opportunity. Pursuant to Wyo. Stat. § 1-1-123, any person who takes part in any sport or recreational opportunity assumes the inherent risks in that sport or recreational opportunity, whether those risks are known or unknown, and is legally responsible for any and all damage, injury, or death to himself or other persons or property that results from the inherent risks in that sport or recreational opportunity. By signing this waiver, I am asserting that my participation in any sport or recreational activity is voluntary and that I am assuming the inherent risks associated with such activity.

I hereby release, waive, discharge, and covenant not to sue, the City of Laramie, Wyoming, a municipal corporation, nor any of its agents, volunteers, assistants, or employees from any and all claims arising in direct relation to my assumption of risk. This is not to include actions based upon negligence of the provider wherein the damage, injury or death is not the result of an inherent risk of the sport or recreational opportunity pursuant to Wyo. Stat. § 1-1-109 and § 1-39-106.

**I have read and fully understand this waiver of liability and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by the law.**
